

# **Harris County Watersheds**






March 2016 Rainfall 200% to 400% of normal for Harris County








#### Channel Status – Tax Day 2016 – 800 am







### **Peak Flood Level Frequencies**









FLOODING WILL LIKELY HAMPER TRAFFIC AROUND THE RESERVOIRS. SEVERAL ROADWAYS ARE CLOSED INCLUDING PARTS OF HIGHWAY 6, CLAY RD, ELDRIDGE PARKWAY AND WESTHEIMER PARKWAY.

FLOOD WATERS COULD ALSO IMPACT STREETS IN SECTIONS OF BEAR CREEK VILLAGE, AND LAKEFOREST OF KELLIWOOD, AND CINCO RANCH WHICH BORDER THE RESERVOIR.



#### **Flood Facts**

Due to extremely intense rainfall rates, 40,000 + cars/trucks flooded Significant overland flooding

Nine fatalities related to the flooding (No one died in their home or work place)

Federal disaster declaration April 25 for individuals; public assistance added June 3

As of 5-19-16, 17,000 people signed up requesting Individual Assistance.
